

MEMORANDUM OF UNDERSTANDING BETWEEN SOUTHERN WEST VIRGINIA COMMUNITY AND TECHNICAL COLLEGE AND BLUEFIELD STATE COLLEGE



FOR THE DELIVERY OF A COLLABORATIVE BACCALAUREATE DEGREE PROGRAM IN CRIMINAL JUSTICE

This is a Memorandum of Understanding (MOU) for the delivery of the baccalaureate degree in Criminal Justice as a collaborative program between Southern West Virginia Community and Technical College (Southern) and Bluefield State College (BSC). This MOU specifies the criteria required to conduct the baccalaureate degree in Criminal Justice for students residing in Southern's service district and the southern mountains region of the State. The first two years of course work in Southern's Criminal Justice Associate in Applied Science degree program has been aligned with the first two years of course work in the BSC baccalaureate degree in Criminal Justice. Under the terms of this agreement, students successfully completing the requirements for completion of the designated program shall be awarded the baccalaureate degree from BSC.

Criteria

- Any student who has completed an associate degree may enter the collaborative program.
- Southern graduates admitted to the collaborative baccalaureate program will be provided with local access to the necessary services of the Admissions, Financial Aid, Registrar, Bursar offices of BSC in order to complete the admissions and registration processes.
- 3. Southern graduates who enter the collaborative program must apply for and meet the admission requirements as transfer students at BSC.
- 4. BSC requires a minimum of twenty (20) students to comprise each program cohort. For each cohort admitted, every student shall be guaranteed access to all courses required for program completion so long as she/he remains academically eligible.
- 5. BSC will deliver courses providing for a full-time student load (12 plus hours) each semester.
- 6. Courses in the collaborative program will be delivered using flexible delivery modes including traditional on-site courses and limited use of distance learning technologies as needed to ensure delivery of the entire program.

- 7. BSC will deliver the entire program at Southern's Wyoming/McDowell Campus. The schedule for the delivery of courses will be determined based upon student demand and instructor availability. Any schedule requested outside the normal campus operating hours of the Wyoming/McDowell Campus must be approved by the Director of Campus Operations.
- 8. Students enrolled in the collaborative program will be provided with the opportunity to complete any required field and/or clinical experiences within the general area of Southern's service district so long as acceptable placements are available within the district.
- 9. Southern will provide appropriate classrooms and access to the Interactive Video Classroom for delivery of courses on a scheduled basis. Southern will provide, on a space available basis, office space as needed by BSC. BSC will be required to provide all necessary office equipment for the space (computer, printer, phone, etc). Local and domestic long distance calls will be free of charge. BSC will be provided with an access code for use of the copier/fax and will be charged \$0.12 per copy or fax.
- 10. The Director of Campus Operations for the Wyoming/McDowell Campus will work in cooperation with BSC officials in making all logistical arrangements.
- Appropriate BSC and Southern academic personnel shall develop an articulation agreement to guide students in degree planning and assist in advising.
- 12. BSC will hire all instructors and will provide each instructor with all necessary instructional and course-related materials required for each course. Course syllabi will be the same as those used for the course as taught on the BSC Campus.
- 13. BSC will specify texts to be used and provide easy access for participating students to purchase required texts and related materials.
- BSC will conduct informational sessions for prospective students on a scheduled basis.
- 15. BSC will provide appropriate advertising and promotion for the program in cooperation with Southern's Communications Department.
- 16. BSC will provide on-site advising, registration, and financial aid information and services.
- 17. BSC will establish student financial accounts and provide for collection of student tuition and fees.

- 18. BSC will confer appropriate degrees upon students successfully meeting all program and institutional graduation requirements.
- BSC will award to students entering the program the maximum number of transfer credits permitted by policies of the Higher Education Policy Commission.
- 20. All program students are responsible for successful completion of all courses, or acceptable equivalents, of the curriculum as outlined in the BSC *General Catalog* (excerpt from the 2010-2012 *Catalog* attached).

Governance

The Baccalaureate Degree Program in Criminal Justice will be under the authority of BSC and BSC will be responsible for the day-to-day activities including, but not limited to scheduling, coordination of facilities, and registration.

<u>Personnel</u>

BSC will employ the baccalaureate-level staff, specific program advisors, faculty, and facilitators.

Southern will provide necessary technical assistance to ensure the operations of the physical plant and required telecommunications systems.

CRIMINAL JUSTICE ADMINISTRATION

The Bachelor of Science degree in Criminal Justice Administration prepares students for a variety of careers in the field of Criminal Justice. Graduates of the program may find employment as police officers, correctional officers, probation or parole officers, or counselors at the local, state, and federal level. The Criminal Justice Administration curriculum offers a choice of majors in either law enforcement or corrections.

The program of study follows a recommended eight semester format. Students should be aware that certain factors may require deviation from the recommended schedule, and that completion of the degree could require longer than eight semesters. Entering students, who have already completed an associate degree in criminal justice or the equivalent from an accredited institution may transfer in and be admitted at junior status in the particular specialization chosen. They can then earn the baccalaureate degree by completing the general studies program and those courses specified for the third and fourth year of the major. Up to 72 hours of credit from all regionally accredited community colleges may be applied toward the degree; all hours transferred in will be entered on the transcript and will be calculated in the students' GPA at Bluefield State College.

Up to 13 credit hours will be awarded to individuals within this discipline who present to the registrar a photocopy of graduation certificate from an accredited police academy or an accredited state or federal correctional academy. Additional credits may be awarded in accordance with articulation agreements made by Bluefield State College and various institutions. The minimum credit awards are:
