1. Call to Order

Chair Howard Seufer declared a quorum present and convened the meeting at 10:00 a.m.

2. Approval of August 30, 2017 Meeting Minutes

3.1 President's Evaluation

Chair Seufer called for a motion to enter into Executive Session under the authority of WV Code §6-9A-4 to discuss the following: President's Evaluation

Dr. Anne Cline requested to present a statement from the Faculty Senate. Chair Seufer stated that today's meeting was not to receive additional comments, but to discuss the evaluation report. Chair Seufer deemed that no action was required by the Committee at this time. Dr. Cline left the meeting.

Ms. Wilma Zigmond made a motion to enter into Executive Session for the purpose of discussing the president's evaluation report. Ms. Jada Hunter seconded the motion. The motion carried unanimously and the Committee entered in Executive Session at 10:05 a.m.

Ms. Hunter seconded the motion. The motion carried unanimously and the Committee convened in a public session at 11:25 a.m.

Chair Seufer called for a motion to approve the draft President's Evaluation with changes as discussed, to provide the report to President Gunter and request his response to bring back to the next meeting, and to extend a contract renewal to the President. Ms. Melissa Deskins motioned to approve the President's Evaluation as amended, to provide the report to President Gunter for his response, and to extend a contract for renewal. Ms. Wilma Zigmond seconded the motion. Voting Aye: Deskins, Hunter, White, Zigmond (4). Voting Nay: None (0); Abstain: Alderman (1). The motion carried with all members voting in favor and Mr. Alderman abstaining. Chair Seufer declared the motion approved.
